## 1. Call to Order

Alma Deckard called the meeting to order at 5:30 pm.

**2. 2016-17 FY AUDIT REVIEW** – To review the 2016-17 fiscal year audit with auditors from Pattillo, Brown and Hill, LLP.

Mr. Juarez address the Council reviewing the 2016-17 audit report. The combination of Assets, liabilities leaves a net position of \$4,240,854. The fund balance is \$784,194, of which \$294,000 is committed for street improvements.

The ending revenue for the year was \$1,653,550, compared to ending expenditures of \$1,742,229. Revenues were short \$88,000 to meet expenditures.

There is an availability of funds to operate for 3.8 months.

Council Member Carter questioned the amount of \$18,350, prior period adjustment on page 31 of the report. Mr. Juarez stated that this adjustment was because the ending balance from the prior year audit report and the beginning balance did not match.

Mr. Juarez stated that the management letter only had one item; of 40 payable records inspected, 4 did not have canceled invoices. This is a requirement to avoid any duplicate payments.

Council Member Howard made a motion to adjourn meeting at 5:433 pm, Committee Member Salazar seconded the motion. Mayor Houston, Council Members Carter, Howard, Davalos, Gonzalez, Worrell and Committee Member Salazar voted "aye" to approve, motion carried.
